Announcement of changes in share capital

Bergamo, 22 July 2011 - We inform you of the new composition of our share capital (fully subscribed and paid up) following:

- on 24/6/2011, the exercise of option rights to increase the share capital and the consequent issue of 242,331,448 new shares;
- on 5/7/2011, the partial conversion of *Obbligazioni UBI 2009/2013* bonds into 240 new shares;
- on 7/7/2011, the conversion of *Warrant UBI 2009/2011* warrants into 19,309 new shares;
- on 11/7/2011, the exercise of options unexercised at the end of the offer period with the issue of 5,706,984 new shares;
- on 18/7/2011, subscription of 14,542,512 new shares by members of the underwriters' syndicate.

The new share capital therefore amounts to 2,254,366,897.5 euro – divided into 901,746,759 shares of 2,50 euro each. The relative filing with the Bergamo Company Registrar was performed on 21st July 2011.
